Go past the library and Chapel by the Lake until reaching the highway. Turn left and go down to the Brotherhood Bridge parking lot. Run down the river trail and River Road. Turn left onto Back Loop and head to the 3-way intersection at Deharts. Continue on, staying on the left side, until reaching the UAS/Fritz Cove 4-way intersection. Turn left and finish back where you started.
